Section 1: Selling Commission

- A. Calves & Yearlings \$ 16.00 per head over \$ 46.00
- B. Calves & Yearlings \$ 8.00 per head under \$ 46.00
- C. Cows selling by the head \$ 30.00 per head
- D. Pairs \$ 40.00 per head
- E. Weigh Cows \$ 20.00 per head
- F. Bulls over 1000 lbs. \$ 30.00 per head

- G. Horses/Mules \$ 25.00 minimum sale fee or 8% of sale price, whichever is greater

- H. Sheep/Goats \$ 7.00 per head over \$16.00
\$ 3.00 per head under \$16.00
- I. E/L & N/K Unit \$ 7.00 per unit

- J. Hogs \$ 7.00 per head over \$16.00
\$ 3.00 per head under \$16.00
- K. Pig/piglet unit \$ 7.00 per unit

Section 2: No Sale & Resale Commission

- A. No Sale Fees
 - \$ 12.00 per head Weigh cows, Calves & Yearlings
 - \$ 30.00 per Pair
 - \$ 25.00 per head Cows selling by the head, & Bulls over 1000#
 - \$ 25.00 No sale fee on horses
 - \$ 5.00 per head on sheep, goats and hogs

- B. Resale commission, yardage, check off, and brand inspection fees applied to livestock resold before leaving the yards. Resale commission is a full selling commission and yardage amount.

Section 3: Yardage

- A. Cattle \$ 1.00 per head with a \$ 5.00 minimum
- B. Horses \$ 5.00 per head
- C. Sheep/Goats \$ 1.00 per head
- D. Hogs \$ 1.00 per head

Section 4: Feed

- A. Feed prices will be available upon request.

Section 5: Veterinary Services

- A. The schedule of charges on all necessary veterinary services performed by an accredited veterinarian will be posted, uniform per head rates, pursuant to company agreement with the veterinarian performing such services.

Section 6: Insurance

- A. The schedule of charges will be rates pursuant to an insurance policy on file and will be available upon request. The schedule does not contain any charges retained by the market.

Section 7: Special or Unusual Services

- A. Special selling and marketing services, such as those involved in featured registered cattle and special calf or cow sales, not usually required in handling livestock for sale and other than specified, will be charged for under special arrangement.

Section 8: Check Off & Brand Inspection

- A. Check off money will be collected as stated by law.
- B. Brand inspection will be collected as stated by law.
